This agreement to waive fees and/or reimburse operating expenses with respect to the SA U.S. Fixed Income, SA Global Fixed Income, SA U.S. Core Market, SA U.S. Value, SA U.S. Small Company, SA International Small Company, SA Emerging Markets Value and SA Real Estate Securities will remain in effect until October 28, 2021, at which time it may be continued, modified or eliminated and net expenses will be adjusted as necessary. The Adviser has contractually agreed to waive fees and/or reimburse expenses so that the Fund's total annual operating expenses (excluding interest, taxes, brokerage commissions, acquired fund fees and expenses and extraordinary expenses) do not exceed the total annual acquired fund fees and expenses related to the Fund's investments in the Underlying SA Funds, any other investment companies advised or sub-advised by the Adviser, or any money market fund. This expense limitation will remain in effect until July 1, 2025 and may be amended or terminated before such time only with the approval of the Board of Trustees of the Fund.
