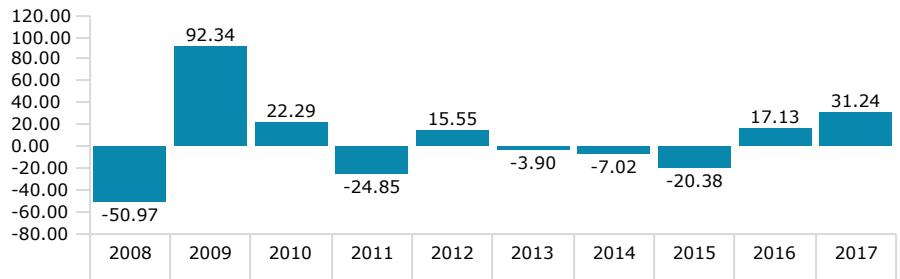

The Fund's goal is to achieve long-term capital appreciation. The Fund pursues its goal by purchasing a broad and diverse group of equity securities of companies in emerging markets that the Sub-Advisor considers to be value stocks. The Fund seeks to achieve its goal by investing in companies in countries with emerging markets designated by the Investment Committee of the Sub-Advisor from time to time as approved markets. As of the current prospectus, the Fund is authorized to invest in the following Approved Markets: Brazil, Chile, China, Colombia, the Czech Republic, Greece, Hungary, India, Indonesia, Malaysia, Mexico, the Philippines, Poland, Russia, South Africa, South Korea, Taiwan, Thailand, and Turkey. The Investment Committee of the Sub-Advisor may authorize other countries for investment in the future, in addition to the Approved Markets listed above.

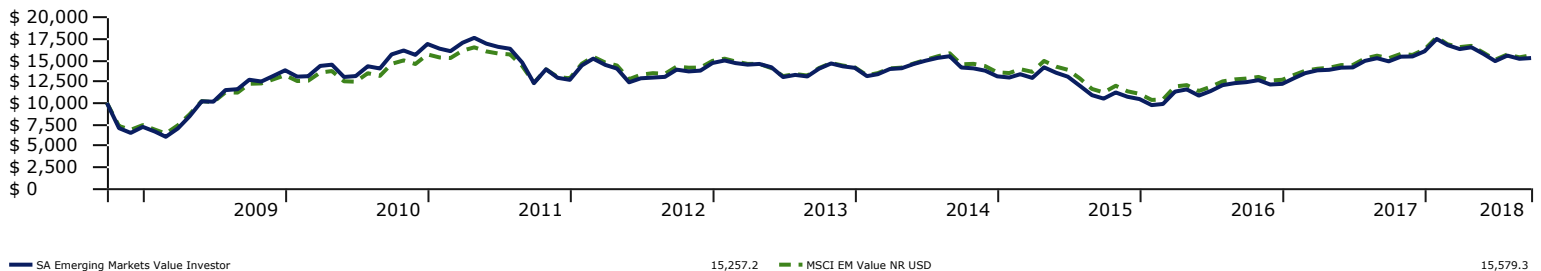

This expense limitation will remain in effect until October 28, 2021 and may be amended or terminated before such time only with the approval of the Board of Trustees of the Fund.
